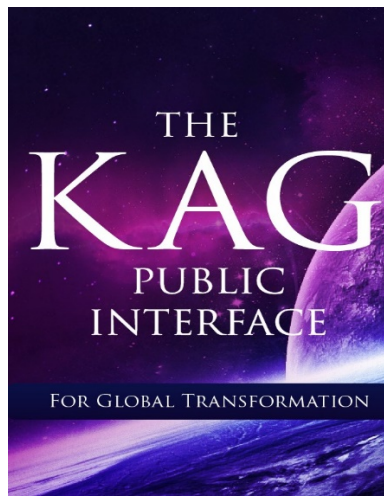

**RE: UPDATED 'SHAREHOLDING PROMISSORY NOTE'**

This letter replaces my letter *Ref: KPI-2021 [EMP 017]* of 12 October 2021, which had forwarded the initial version of the 'Shareholding Promissory Note'.

It has become necessary to update that initial version of the 'Shareholding Promissory Note' following the recent registration of the holding company under the name and style of *worldNEXT(LTD)*, as per the attached Certificate of Incorporation (the name **ONEworld** was not available). The updated 'Shareholding Promissory Note' is as per Sheet Serial No. 5; while at Sheet Serial No. 6 is a blank fillable version which you can use to refer your own individual or corporate nominee, or to refer a co-director (this same blank fillable version is linked at the website as an MS Word document).

As an early attempt to streamline branding across the holding company and the proposed subsidiaries, the following are the new proposed names and styles of the 4 planned subsidiaries: *communityNEXT(LTD)* for *kBase*, *languageNEXT(LTD)* for *The Humanese Initiative*, *moneyNEXT(LTD)* for *Omega Xpress*, and *marketNEXT(LTD)* for *kMart*. Before this proposed business ecosystem converts into the originally planned global kingdom, extensive and comprehensive rebranding will need to be undertaken, to cloth the ecosystem in kingdom branding.

The purpose of registering the holding company was to confirm the availability of a suitable business name and to give the 'Shareholding Promissory Note' added significance. Please note that the Memorandum and Articles of Association for *worldNEXT(LTD)* are still the model ones that

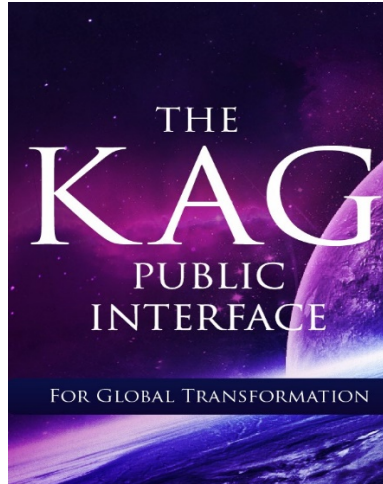
